



Amateur Athletic Union (AAU) **MEMBERSHIP** (REQUIRED)

Each athlete must have a non-expired AAU Membership in order to participate in any qualifying meets and subsequent AAU Junior Olympic National meet (Cross Country and/or Track & Field). Your membership must be completed PRIOR to being registered for the first qualifying meet. When you create a new membership, you must use the FPYC club code to associate the athlete with FPYC Cheetahs. If you do not use the club code, then the FPYC directors cannot add your child to the team roster. Prior members should check that the club code on their account matches the one below. If not, families must update their child's AAU account and change the club code to match the FPYC club code. AAU memberships run from Sept. 1st in one calendar year to August 31st in the next year. You can purchase multi-year memberships.

2. Our FPYC AAU-Club Code is W3846F through 8/31/23. The club code changes with each renewal year.
3. Date of birth verification is not required by the AAU. However, if contested, an athlete must show proof of date of birth (birth certificate or passport).
4. When you sign-up for the first qualifying meet on the Sign-Up-Genius, put your membership number with your name and t-shirt size. We will complete the necessary meet registration.

FPYC is affiliated with the Potomac Valley Association Region (not the Virginia Region).



USA Track & Field (USATF) **MEMBERSHIP** (REQUIRED)

Each athlete must have a non-expired USATF Membership in order to participate in any qualifying meets and subsequent USATF Junior Olympic National meet (Cross Country and/or Track & Field). The membership AND birthdate verification must be completed PRIOR to being registered for the first qualifying meet. When you create a new membership, you must use the FPYC club code to associate the athlete with FPYC. If you do not use the club code, then the FPYC directors cannot add your child to the FPYC team roster. Make sure to get the membership in your child's name.

1. [Individual Membership Application Form](#) (new or renewal). Or go to USATF.org and access the membership registration. Our FPYC USATF Club Code is #947. It could also say 0947 or 10-0947 in the system.
2. New USATF members must also complete the verification of birthdate. This is now completed during the registration process. Once the birthdate is verified, it does not need to be done again, even when renewing the membership. The athlete's birth certificate should be uploaded under the Athlete Verifications tab on their member profile page.
3. When you sign-up on the sign-up genius, we only need your child's first and last name. If you have done all the steps (getting the membership with the FPYC club code and doing the DOB verification), your child will show up correctly in the system. Therefore, we do not need their membership number.
4. If your child belonged to a different USATF running club and is now part of FPYC, you will need to call the USATF Potomac Valley Association Membership to get it switched to FPYC.
